RECOGNITION ORDER

WHEREAS in terms of section 14(1)/15(1) of the NCTE Act, 1993, the institution had submitted application to the Northern Regional Committee of NCTE for grant of recognition/permission for Teacher Education Course.




Dear Sir/Madam,

This is to inform you that the Inspection Committee which visited your college has pointed out the following deficiencies in its report dated **29.04.2019** (copy attached):-

1.	BA.B.ED 3 rd year-50 seats	<ol style="list-style-type: none"> The College is required to purchase books worth Rs. 10,000/- Sage, Pearson books may be added. The College is required to appoint (i) Assistant Professor-02 (Perspective, and Pedagogy) (ii) Principal/HOD-01. P.F. should be deducted after probation and annual increment given to the existing faculty.

The college must fulfill the above said deficiency by **30.06.2019**.

The College is required to report fulfillment and compliance of the above referred deficiencies which are mentioned in the inspection report immediately from the issue of this letter. The delay, if caused in sending compliance of the conditions imposed, the College shall be responsible and the matter shall also be referred to the Syndicate for taking decision it may deem appropriate.

This may be treated as **Most-Urgent**.
